INFORMATION FOR THE STUDENT:

1. Must be enrolled as a full-time student in a college or university.
2. Student must have completed high school and graduated and have completed their first year (or more) of college.
3. Must be majoring in an agricultural-related field (includes horticulture, forestry, ag-business, etc.).
4. Must be a resident of Erie County.
5. Parent(s) or student must be an Erie County Farm Bureau member and membership must be currently paid. (For membership information call 440-877-0706 or 888-216-5487)
6. Payment for the scholarship will be made to the student after the following:
 - payment receipt for spring quarter/second semester fees (2018)
 - 2.5 GPA or better for the first quarter/semester
 - must be continuing his/her education in an agricultural field
7. A current college transcript must be attached to the application form; a 2.5 minimum grade point is required for consideration.
8. A signed statement of reference from both a non-school individual: a minister, 4-H advisor, or other volunteer leader (not a family member) and a school-related individual must be attached.
9. A scholarship committee will screen applications and may interview finalists to select the best prospective student for this scholarship. You may be contacted for a personal interview.
10. Please attach a recent photo of yourself.
