Lemon Law Defined. A lemon is a vehicle with a substantial defect. In order to be covered by state Lemon Law protections, a vehicle must have a (1) substantial defect that is covered by a warranty and occurred within a certain mileage or period of time, and (2) the defect must remain unfixed after a reasonable number of repair attempts.

In California, a vehicle is presumed to be a "lemon" by the Song-Beverly Consumer Warranty Act if, within 18 months of the vehicle's delivery to the buyer (or 18,000 miles on the odometer): 2 attempts or more have been made by the manufacturer to repair a warranty problem that could result in death or serious injury.

A warranty is a manufacturer's or seller's promise to stand behind its product and correct problems if the product fails due to a manufacturing defect or because it doesn't work as promised. The federal Magnuson-Moss Warranty Act governs written warranties on consumer products and protects consumers.
