The annual report must be filed by an officer of the corporation who is listed in the report's section for officers. A maximum six officers and six directors may be entered via the web form. The registered agent and/or registered office cannot be changed via an electronically filed annual report.

Corporation Annual Report Business Services

Benefit corporations must provide an annual benefit report according to a third-party standard (such as B Lab) and make the report available on their company Web sites. The purpose of this is to assess the company's performance with regard to its public purpose(s). Annual Fees to Retain Certified B Corp Status.
