A bilateral investment treaty (BIT) is an agreement between two countries regarding promotion and protection of investments made by investors from respective countries in each other's territory.

In this context, Brazil signed 14 agreements on investment promotion and protection (hereinafter BITs) with Germany (1995), Belgium-Luxemburg (1999), Chile (1994), South Korea (1995), Cuba (1997), Denmark (1995), Finland (1995), France (1995), Italy (1995), The Netherlands (1998), Portugal (1994), United Kingdom (1994), Switzerland (1994), and Venezuela (1995).<sup>11</sup> Brazil's participation in the creation of these agreements is marginal at best.
